At the Paris climate talks, we stood shoulder to shoulder with those communities most affected by climate change.

# You pressure Department of Justice to investigate British American Tobacco

Challenging Big Tobacco's illegal bribery conspiracy

"We won't let British American Tobacco get away with bribing politicians and breaking the law. We will use the full force of the global tobacco treaty to make BAT pay."

British American Tobacco (BAT) has the largest share of cigarette sales in Africa—and to protect these profits, it committed crimes at the expense of people's health.

In a hard-hitting exposé, the BBC revealed that BAT paid bribes in five East African countries to undermine tobacco legislation.

Members like you are not standing for such a blatant violation of the law. As soon as the news broke, you joined us and allies to launch a global campaign to hold BAT accountable for bribing politicians, blocking public health laws, and undermining democracy.

Soon after the documentary aired, we joined Rep. Lloyd Doggett (D-TX) to rally members of Congress to call for a Department of Justice investigation into BAT's abuses.

With the public outcry you've helped amplify, we will make sure BAT pays for its illegal actions.

# What did you learn from doing Climate Ride, a five-day bike ride to raise awareness about climate change?

It was eye-opening for me as someone who was never involved in environmental issues before. People of all ages rode from Acadia in Bar Harbor, Maine to Boston to bring attention to climate change. Riding on behalf of Corporate Accountability International, I had a chance to talk about how corporations interfere with climate negotiations. There was a renewable energy group that fought a major campaign in the face of corporate influence—and it persevered and won. I heard so many great stories about what organizing can accomplish.



## Why do you support Corporate Accountability International?

I'm amazed by how you organize. I know that a lot of planning goes into each campaign and the results show that. With the National Park Service, for instance, big corporations are trying to control it. But you've organized people to build a movement while working with political leaders to create good policy.

## What's a memorable volunteer experience you've had here?

In December I helped the national water campaign with its organizing to block a bill that would make it difficult for our national parks to go bottled water free. Before the team traveled to Washington, D.C., I printed thousands of petitions that people signed so they could be delivered in Congress. It was a small thing, but I hear that it was part of the reason 34 members of Congress stood up for our national parks and ultimately defeated the amendment.

# Unions challenge McDonald's

You join educators to end kid-targeted marketing

Students across the country learn formative lessons, including how to be healthy, from teachers. But via McTeacher's Nights, McDonald's exploits that trust by having teachers sell burgers, fries, and soda to their students. Meanwhile, schools often raise less than a dollar per student. During McTeacher's Nights, McDonald's reaps the kind of marketing money can't buy by associating respected teachers with its junk food brand.

To break the spell of this dangerous marketing, we launched an initiative with Campaign for a Commercial-Free Childhood, the National Education Association, and teachers' unions across the country.

Members like you ensured that news outlets across the country amplified this call to end McTeacher's Nights. The Washington Post published a frontpage investigation into McDonald's school-targeted marketing.

McDonald's has become one of the world's best-known brands through such aggressive marketing—and it's made children customers for life. By challenging McDonald's insidious tactics, we are helping create a food system that nourishes us rather than makes us sick.

## Advancing the human right to water in India

You expose the danger of the World Bank's water privatization plans

In parts of Nagpur, India, there are days when the water does not flow. People like Usha Shende wait for the small window—30 minutes every other day-when it returns, and then the waiting begins again.

Meanwhile, a subsidiary of the giant water corporation Veolia profits from managing the city's water system. It does so by raising prices, shutting off access for those who can't afford to pay, and skimping on maintenance critical to the water supply's safety.

If plans remain on course, Nagpur won't be the only city in India grappling with this disaster. The World Bank is promoting this failed model in

hundreds of cities across the country, despite its devastating results.

But you are standing with the people of Nagpur and exposing the truth behind the World Bank's PR. As the world hears their stories, we're clearing the way for the solution: democratically accountable, public water systems.
