

## STATEMENT OF SUPPORT FROM ADVOCATES

We applaud WHO's commitment to the [WHO Framework of Engagement with Non-State Actors \(FENSA\)](#) which embodies the WHO Framework Convention on Tobacco Control's (WHO FCTC) policy of protecting public health from the commercial and vested interests of the tobacco industry. This commitment is also consistent with Article 5.3 of the WHO FCTC which requires parties to reject partnerships and collaborations with tobacco companies. We support WHO's decision to put on hold Medicigo's (Medicago Inc.) request for prequalification for emergency distribution of Covifenz, in light of the significant ownership by Philip Morris International (PMI).<sup>1</sup>

**WHO has confirmed that it made this decision due to the conflict of interest arising from Medicigo's ties with PMI.**<sup>2</sup> To uphold the integrity of the WHO FCTC and the WHO FENSA, it is imperative that Medicigo Inc. divests its tobacco interests. In a July 2020 press statement, Medicigo already revealed that one of its co-owners, PMI, was open to assessing better-suited investors,<sup>3</sup> but it has not done so. Canadian health groups are also urging the Canadian government to compel Medicigo to remove its tobacco interests, instead of forcing WHO to bend treaty rules,<sup>4</sup> undermining institutional integrity.

**We ask WHO to stand firm in its position.** A [briefing paper](#) describes how **the tobacco industry could use a tobacco-based vaccine to further its so-called Corporate Social Responsibility activities, especially in Low-and-Middle-Income Countries (LMICs), and undermine hard-fought life-saving tobacco control policies.** Concerns about the tobacco industry's pharmaceutical strategy are shared by countries around the world. In November 2021, Parties to the WHO FCTC raised concerns that **tobacco industry acquisitions in the pharmaceutical sector "could complicate and hinder tobacco control implementation.**<sup>5</sup> For instance, it could lead to tobacco companies benefiting from government incentives awarded to tobacco-owned pharmaceutical companies, when the WHO FCTC commits governments to not give incentives to tobacco companies to run its business.<sup>6</sup>

Tobacco use claims over eight million lives annually, which exceeds the total death toll from COVID-19,<sup>7</sup> and tobacco industry interference has been described as the [largest barrier to tobacco control](#) globally. We trust that WHO will be steadfast in its effort to protect public health policies from the commercial and vested interests of the tobacco industry.
